The program of the entrance exam for applicants to the PhD for the group of educational programs D069 – «Library science, information processing and archival science»

1. General provisions.

- 1. The program was drawn up in accordance with the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018 No. 600 "On Approval of the Model Rules for Admission to Education in Educational Organizations Implementing Educational Programs of Higher and Postgraduate Education" (hereinafter referred to as the Model Rules).
- 2. The entrance exam to doctoral studies consists of an interview, writing an essay and an exam on the profile of the group of educational programs.

3. The duration of the entrance exam is 4 hours, during which the applicant writes an essay, passes a test for readiness for doctoral studies, and answers an electronic examination. The interview is conducted on the basis of the university before the entrance exam..

2. Procedure for the entrance examination.

1. Applicants for doctoral studies in the group of educational programs D069 – «Library science, information processing and archival science» write a problematic / thematic essay. The volume of the essay is at least 250 words.

The purpose of the essay is to determine the level of analytical and creative abilities, expressed in the ability to build one's own argumentation based on theoretical knowledge, social and personal experience.

Types of essays:

- motivational essay revealing the motivation for research activities;
- scientific-analytical essay justifying the relevance and methodology of the planned research;
- problem/thematic essay reflecting various aspects of scientific knowledge in the subject area.

Essay topics:

1. Express an opinion on usage of Internet in innovative activity and periodicals in the sphere of archival files

- 2. Analyze the causes of staying behind of documentary working outs of normative and methodical character from tempo of development of informational technologies and changes of authentic documentary information
- 3. Illuminate the world practice of innovative resources management and point out the actual problems during the globalization period of informational resources
- 4. Illuminate the influence of informational and communicative technologies on social development, economics, social sphere and documentary processes
 - 5. Internet sites of archives: problems and perspectives of development
 - 6. Virtual reference service for remote users: state, development trends
- 7. Problems and prospects of international bibliographic cooperation development at the present stage
 - 8. Library as a social institution: role and functions
 - 9. Describe the directions of development of archives and libraries in modern society
- 10. The current problems in the system of training, retraining and advanced training of library and archive specialists in Kazakhstan
 - 2. The electronic examination card consists of 3 questions.

Discipline «Theoretical Problems of Archival Studies»

Topic 1. The general theory of the document (archival aspect)

A document as an object of study of archival studies. The purpose, objectives, aspects of the general theory of the document. Social functions of documents. Problems of origin of types of documents. Topic 2. Archival terminology. Works in the field of archival terminology

B.S. Ilizarov and the concept of archives as the social memory of mankind. V.N. Avtokratov, B.S. Ilizarov on the formation of the terms "archive", "archival document" (1989). The development of the concept of "archive fund" in archival studies of the XX century. The concept of "documentary fund" and the prerequisites for its appearance. The concept of the founder.

Legal consolidation of the main archival terms in the Law of the Republic of Kazakhstan "On the National Archival Fund and Archives" (dated December 22, 1998) (changes dated 10.28.2015 No. 368-V). Dictionaries of archival terminology. Comparative analysis of the main archival terms of foreign countries.

The concepts of "archival science", "archival business", "fund", "archival document", "theory and methodology of archival science", "next fund", "archival fund". The ratio of the concepts of "information" and "document". Key document concepts.

Sources of acquisition of archives. The concepts of "source of acquisition" and "zone of acquisition".

The conceptual apparatus of modern information technology. The development of the ideas of fundamental archiving in the works of V.P. Kozlova, O.M. Medushevskaya, I.V. Karapetyants, V.M. Magidova, E.V. Starostina, T.I. Horchordina.

Topic 3. The object and subject of archival studies

V.N. Autocrats about the subject and object of archival studies. The development of the concept of the "foundation" and the "principle of origin" as the theoretical core of the new science of archives. Authorship of the basic concepts of archival studies (V.K. Klein, V.V. Snigirev, G.S. Gabaev).

Object of archiving: a system of archival institutions, documentary resources on paper and other media, archive management tools, scientifically-mincer The object of archival studies: documented retrospective information.

The subject of archival studies at the empirical, theoretical and methodological levels.
