**Program of entrance exam  
on educational programs of bachelor's degree  
of the «International Relations» Faculty  
for foreign citizens on a paid basis  
for the branch of NAO KazNU named after al-Farabi in Omsk**

**1. General provisions**

1.1. The program was drawn up in accordance with the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018, No. 600 "On approval of the Model Rules for admission to education in educational organizations implementing educational programs of higher and postgraduate education" (Hereinafter - the Model Rules).

1.2. Entrance exams are conducted in interview format in the following educational programs:

**40.03.01 - Jurisprudence**

**6B04201 - International Law**

1.3 For the organization and conduct of entrance examinations for the admission of foreign applicants by the decision of the rector of KazNU named after Al-Farabi is created examination subject commission for the academic year.

The composition of the commission of entrance examinations for admission of foreign applicants to KazNU includes employees of the Department of Internationalization and Recruitment (hereinafter - DIR) and faculty of KazNU.

1.4. In case a foreign applicant, who meets the above requirements, has no opportunity to come to the University to pass the entrance interview, he has the opportunity to pass it in online format.

1.5 Entrance examinations in the form of an oral conversation (interview) for admission of a foreign applicant are evaluated according to the 100-point system. At admission on a paid basis 65 points are counted.

1.6 According to the results of the entrance examination, a protocol of the interview in the established form is drawn up. The protocol of the interview is signed through the system "Salem office" by the chairman and all present members of the commission and transferred to the DEIR.

1.7 The decision on admission is considered by the competition commission on admission of foreign applicants and is formalized by the protocol through the system "Salem office". The results of the entrance exam are announced on the day of the exam.

1.8. It is not allowed to retake the entrance exam.

1.9. An appeal on the results of the interview is allowed within 24 hours.



## **2. Conducting the entrance exam in 2025**

2.1 The interview is conducted in Russian, Kazakh and English. The oral interview also contains questions aimed at revealing the ability to learn, creative activity and criticality of thinking, the personal qualities of the foreign applicant.

### **Topics for questions:**

1. Forms of government
2. Political regimes
3. United Nations
4. Diplomatic relations
5. Law of international organizations

### **Exam questions**

First level of questions:

1. Feudalism as a form of social structure
2. Capitalism and its main features
3. Communism as an ideology and social structure
4. The United Nations: goals, structure and significance
5. International recognition of the USSR after the Great October Socialist Revolution.

Second level of questions:

1. Russia as a founding member of the United Nations
2. Confrontation between the USSR and the USA during the Cold War
3. Democratic reforms in the USSR in the late 1980s
4. The role of the UN in the formation of modern international law
5. Development of diplomatic relations between Kazakhstan and Russia after the collapse of the USSR

Third level of questions:

1. International legal status of the Commonwealth of Independent States (CIS)
2. Concept and types of subjects of international law
3. Contribution of Kazakhstan to the victory of the USSR in the Great Patriotic War
4. The role of the USSR in the formation of the UN
5. The Collective Security Treaty Organization (CSTO) and its role in international security
