

Program of entrance exam
on educational programs of bachelor's degree
of the Faculty of Law
for foreign citizens on a paid basis
for the branch of NAO KazNU named after al-Farabi in Omsk

1. General Provisions

- 1.1. The program is drawn up in accordance with the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018 No 600 "On Approval of the Model Rules for Admission to Study in Educational Organizations Implementing Educational Programs of Higher and Postgraduate Education" (hereinafter referred to as the Model Rules).
- 1.2. Entrance exams are held in the format of an interview for the following educational programs:

40.03.01 - Jurisprudence 6B04203 - Customs

1.3 For the organization and conduct of entrance exams for the admission of a foreign applicant, by the decision of the rector of Al-Farabi Kazakh National University, an examination subject commission for the academic year is created.

The commission of entrance exams for admission of a foreign applicant to KazNU includes employees of the Department of Internationalization and Recruiting (hereinafter referred to as DIR) and the teaching staff of KazNU.

- 1.4 If a foreign applicant who meets the above requirements does not have the opportunity to come to the University for an entrance interview, he has the opportunity to take it online.
- 1.5. Entrance exams in the form of an oral conversation (interview) for admission of a foreign applicant are evaluated according to a 100-point system. When enrolling on a paid basis, 65 points are counted.
- 1.7. Based on the results of the entrance exam, the interview protocol is drawn up in the prescribed form. The protocol of the interview is signed through the "Salem office" system by the chairman and all present members of the commission and submitted to the DIR.
- 1.8. The decision on admission is considered by the competition committee for the enrollment of foreign applicants and is documented in the protocol through the Salem office system. The results of the entrance exam are announced on the day of the exam.
 - 1.9. Retaking the entrance exam is not allowed.
 - 1.10. An appeal based on the results of the interview is provided within 24 hours.

2. Conducting an entrance exam in 2025

2.1 The interview is conducted in Russian, Kazakh and English. The oral interview also contains questions aimed at revealing the ability to learn, creative activity and critical thinking, personal qualities of the applicant.

An approximate list of topics for the interview:

- Concept, subject and principles of civil procedural law. Conciliation procedures in civil proceedings.
- 13. Concept, objectives and system of criminal law.
- 14. Criminal law as a branch of legal science.
- 15. Tasks of the science of criminal law.
- 16. Tasks and functions of criminal law.
- 17. Criminal liability and its basis.
- 18. Classification of crimes.
- 19. Corpus delicti.
- 20. Criminal offenses against the person.

The first level of questions:

- 1. Reveal the signs and trends in the development of a modern state.
- Analyze various definitions of the state based on the main theories of the essence and origin of the state.
- 3. Reveal the functions of the modern state.
- 5. Reveal the concept of the form of the state.
- 6. Reveal the features of the form of government of the state monarchy and republic.
- 7. Reveal the features of modern republics from the point of view of the form of government.
- 8. Reveal the features of the form of state structure, indicate its types.
- 9. Conduct a comparative analysis of different types of political regimes democratic and anti-democratic.
- 10. Reveal the types of state bodies.

The second level of questions:

- 1. Civil law interests, subjective civil rights, concept, correlation.
- 2. Definition of civil, economic, entrepreneurial turnover.
- 3. Codification of civil legislation. Composition of civil legislation.
- 4. Problems of development of legislation on entrepreneurial activity.
- 5. Civil legal relationship, legal features, distinctive features, problems of definition, types.
- 6. Legal personality, definition and structural components.

- 7. Theories of legal personality of legal entities as independent subjects of law.
- 8. Identification of the subjective independence of state legal entities.
- Problems of correlation between the legal capacity of participants and the legal entity created by them.
- 10. The concept and types of transactions in civil law. Problems of determining a transaction made in the process of entrepreneurial activity.

The third level of questions:

- 1. Criminal policy as one of the directions of state policy.
- 2. The concept and meaning of criminal law, its main content.
- 3. The concept and social essence of crime.
- 4. The importance of establishing the elements of a crime for the application of criminal law. Corpus delicti and circumstances to be proved in a criminal case.
- 5. Criminal Law on the Objects of Criminal Law Protection. Types of objects of crime.
- 6. The concept and meaning of the objective side of the crime, with
- 7. The concept and characteristics of the subject of a crime under criminal law. The subject of the crime and the personality of the criminal. Criminal and legal significance of the personality of the criminal. The problem of criminal liability of legal entities.
- 8. The concept and meaning of the subjective side of the crime.
- 9. Criminal liability as a type of legal responsibility.
- 10. The concept and types of stages of an intentional crime.

3. Scale and Evaluation Criteria for the Bachelor's Degree Entrance Exam for Foreign Citizens on a Paid Basis

Number of points	Eligibility Criteria
86-100 points "Excellent"	All the competencies taken at the entrance exam have been mastered. A complete detailed answer to 2 theoretical questions is given: - scientific terminology is used competently; - all the features, elements, grounds, classifications necessary for substantiation are correctly named and defined; - the main points of view accepted in the scientific literature on the issue under consideration are indicated; - one's own position or point of view is reasoned, the most significant research problems in this area are identified. The practical problem was solved correctly with all the necessary explanations.
79-85 points "Good"	All the competencies taken at the entrance exam have been mastered. The correct answer to 2 theoretical questions was given, minor shortcomings were identified in the preparation: - scientific terminology is used; - all the features, elements, classifications necessary for substantiation are named, but at the same time an error or inaccuracy in definitions and concepts is made; - there are shortcomings in the argumentation, factual or terminological inaccuracies that are not significant; - an idea of possible research problems in this area is expressed. The practical problem is partially solved with an incomplete presentation of the necessary explanations.
65-78 points "Satisfactory"	All the competencies taken at the entrance exam have been mastered. The correct answer to 2 theoretical questions is given, minor shortcomings are identified in the preparation: - only some grounds, signs, characteristics of the phenomenon under consideration are named and defined, - significant terminological inaccuracies are allowed; - own point of view is not presented; - no idea of possible research problems in this area is expressed. The practical problem has not been solved.
0-64 points "Unsatisfactory"	Not all the competencies taken at the entrance exam have been mastered. Incorrect answers were given to 2 theoretical questions, significant shortcomings were identified in the preparation; The practical problem has not been solved.
